
The demand for bilingual healthcare professionals is only increasing as the world becomes more globalized.

- Background Check
- Proof of Hepatitis B vaccination (started or completed); proof of two-step TB skin test
- Application, including personal statement
- Eligible to work in the United States
- Students applying for financial aid/workforce development funding may be required to complete additional screening and career testing
